#### PUBLIC COMMENTS

Members of the public may comment on matters within the TAC's purview that are not on the meeting agenda during the general Public Comment item at the beginning of the meeting. While members of the public are welcome to address the TAC, under the Brown Act, TAC members may not deliberate or take action on items not on the agenda, and generally may only listen.

If authors of the written correspondence would like to speak, they are free to do so and should raise their hand and the Chair will call upon them at the appropriate time.

1. To comment during a Zoom meeting, click on the “Raise Hand” button to request to speak when Public Comment is being taken on the Agenda item. You must unmute yourself when it is your turn to make your comment, for up to 3 minutes. After the allotted time, you will then be re-muted.

2. To comment by phone, press “\*9” to request to speak when Public Comment is being taken on the Agenda item. You must unmute yourself by pressing “\*6” when it is your turn to make your comment, for up to 3 minutes. After the allotted time, you will be re-muted.

### 4. Committee Member Comments

Lorien Clark, City of Napa - the City submitted a Better Utilizing Investments to Leverage Development (BUILD) grant application for the Imola Corridor environmental and design phases that included both City and County sections.

Jessica Lowe, City of Napa - introduced Mike Ryan, the City's new Capital Improvement Program (CIP) Manager.

### 5. Staff Comments

Patrick Band - the draft Countywide Active Transportation Plan (ATP) was released for public comment. He encouraged the jurisdictions to submit the comments, changes or concerns as soon as possible.

Mr. Band also noted that staff will bring a Transportation Development Act Article 3 (TDA 3) Call for Projects (CFP) item to the TAC in April; there is approximately \$400,000 in funding available.

Grant Bailey - Caltrans released a CFP for State-sponsored, non-State Highway Operation and Protection Program (SHOPP) project initiation documents for projects that are on the state highway system but are not currently in the SHOPP. NVTA submitted seven projects to Caltrans including projects on Petrified Forest Road, and improvements on State Routes 29, 121 128, and 221.

Adrell Coleman - Phase 2 of the Transportation Improvement Program (TIP) is underway, which is a full project review of all of the active projects in the TIP. Mr. Coleman will contact each jurisdiction regarding their project reviews.

Diana Meehan - congratulated Jessica Lowe on her appointment as Public Works Director for the City of Napa.

## **6. STANDING AGENDA ITEMS**

### **6.1 County Transportation Agency Report (Diana Meehan)**

Diana Meehan provided updates on the following items that were discussed at the February 27<sup>th</sup> County Transportation Agency (CTA) meeting:

- Caltrans provided a Notice of Funding Opportunities, which is included in the handouts.
- A new Caltrans transit policy (DP40) which aligns with Caltrans' Complete Streets Policy (DP37) and requires Caltrans to establish metrics to evaluate and measure the performance and the need for transit on the state highway system.
- Caltrans created a new Deputy Director position for Transit and Rail and is reinstating its Division of Mass Transportation.
- Caltrans District 4 was the first district to adopt a Transit Plan; Ms. Meehan encouraged the TAC to review it.
- The Metropolitan Transportation Commission (MTC) is close to adopting Plan Bay Area 2050+, pending completion of the supplemental reports and review of comments received.
- MTC will start work on the Plan Bay Area 2060 process sometime this year.
- MTC is in support of extending Regional Transportation Program (RTP) cycles to eight (8) years with the Regional Housing Needs Allocation (RHNA), a consideration being discussed for the SB375 revision.

### **6.2 Project Monitoring Funding Programs\* (Adrell Coleman)**

Adrell Coleman reviewed the improvements he made to the spreadsheets.

### **6.3 Measure U Update (Adrell Coleman)**

Adrell Coleman thanked all the jurisdictions for submitting their semi-annual reports on time.

### **6.4 Caltrans Report\* (Amani Meligy)**

Amani Meligy reviewed the Caltrans monthly report, and provided updates on the two emergency director order projects - the SR29 pavement repair north of Madison Street is complete, and striping will be completed today; the culvert repair work required an all-day single lane closure with reversing one-way traffic control that started on February 26 and will continue for three weeks. Anticipated project completion date is June 2026.

Member Lederer expressed concern regarding the lack of communication regarding lane

closures related to the culvert replacement project, noting that in the monthly meetings since December it was established that all lane closures would occur at night, as SR29 is Napa County's primary thoroughfare and day-time closures would cause a serious impact on traffic flow. The notice of the 24/7 single lane closure was sent out the day before it started, which was not enough time to communicate the closure to the public.

Member Lederer requested a schedule of all lane closures related to the culvert replacement project as well as advance notification moving forward.

Ms. Meligy will forward the schedule to the TAC and discuss the issue with the construction and communications teams.

## **6.5 Vine Trail Update (Eric Janzen)**

Eric Janzen reported on the need to expand the Vine Trail Yountville to St. Helena project's scope and undergo a Transportation Improvement Program (TIP) update before reapplying for E76 approval.

## **6.6 Transit Update (Libby Payan)**

Libby Payan provided the following updates:

- American Canyon Shuttle weekday service has been extended to 7 pm, and for the first time, there is Saturday service from 8:30 am to 5:30 p.m.
- All rides on Vine Transit during BottleRock will be free, thanks to sponsors Latitude 38 and Visit Napa Valley. Service will again be extended past the concert end times.
- Staff is working on the upcoming June and August schedule changes, which will coincide with the end and start dates of local schools.

## **7. PRESENTATIONS**

### **7.1 Project Update - SR29 /12/ Airport Boulevard (Grant Bailey)**

Information only/No Action Taken

Grant Bailey provided an update on the SR29 / 12 / Airport Boulevard project, outlining three selected alternatives: a displaced left-hand turn at-grade option, a direct connector outside merge, and a single-point urban interchange. The next steps include discussing these alternatives with Caltrans for environmental revalidation and planning public participation meetings in April or May.

**RECOMMENDATION**

That the Technical Advisory Committee (TAC) review TDA-3 Program Guidelines and recommend the Napa Valley Transportation Authority (NVTA) Board approve the Program Guidelines and open a Call for Projects at its April 15, 2026, meeting.

**EXECUTIVE SUMMARY**

The TDA-3 program provides grants for local bicycle and pedestrian projects. The program is funded by approximately 2% of the ¼ cent Statewide Sales Tax generated in Napa. This generates approximately \$220,000 per year in revenue for Napa jurisdictions. Unused funds are accumulated and rolled over to future programming cycles. This Call for Projects will be limited to approximately \$250,000 for FY 2026-27 and \$200,000 for FY 2027-28.

TDA-3 project applications will be due to NVTA by 5:00pm on Friday, May 1, 2026. Pursuant to MTC requirements, the NVTA ATAC will review and recommend approval of TDA-3 funding requests at their May 18<sup>th</sup> meeting. Following ATAC approval, the list of projects will go to the NVTA Board for approval on June 17, 2026.

**BACKGROUND & DISCUSSION**

TDA-3 funds may be used for capital infrastructure, maintenance, and/or Quick Build purposes, as well as limited safety education programs, as outlined in Attachment 1. In 2018, the NVTA Board requested a change to NVTA policy that prioritized infrastructure projects for TDA-3 funds.

As of February 2026, the MTC fund estimate for FY 2025-26 is \$224,481.

Historically, smaller jurisdictions have applied for and been supported by the TAC and Board for funding, recognizing the limited competitiveness for alternative sources of bike/ped funding. Nevertheless, all public agencies are eligible to apply for funding, consistent with program guidelines.

For the prior two TDA-3 Calls issued by NVTA, Quick Build projects have been prioritized for funding, recognizing the ability to significantly improve safety and accessibility at the neighborhood level in conjunction with larger or parallel paving or other roadway projects. Staff recommend continuing to prioritize TDA-3 funding for these efforts, consistent with objectives of the Napa Countywide Vision Zero Plan, Local Roadway Safety Plans, Safe Routes to School Plans, and related efforts. Quick Build projects are expected to be delivered on an expedited basis and will have a TDA-3 funding limit of \$50,000 per project.

Jurisdictions are welcome to apply for multiple Quick Build projects but are required to submit a separate application for each project. Applicants considering Quick Build projects are advised to consult the following guidelines and resources to ensure alignment with best practices:

All TDA 3 funded projects are required to meet Caltrans safety design criteria and CEQA requirements; be completed within two years; be maintained; be consistent with adopted active transportation plans; and be authorized by a governing council or board. See Napa County Guidelines for additional criteria and project requirements.

The Napa Valley Transportation Authority (NVTA) is pleased to announce a Call for Projects for Transportation Development Act, Article 3 (TDA-3) funds available to Napa County jurisdictions.

TDA-3 is a grant program under the Metropolitan Transportation Commission (MTC), funded by approximately 2% of the ¼ cent Statewide Sales Tax. This generates approximately \$220,000 per year in revenues for jurisdictions in Napa County. The purpose of the TDA-3 program is to provide funding for local bicycle and pedestrian projects.

The TDA-3 program can fund a wide range of project types including:

- Construction and/or engineering of a bicycle or pedestrian capital project
- Capital purchases for maintenance of a Class I or Class IV facilities
- Enhancement of Class II bicycle lanes
- Bicycle safety education programs (no more than 5% of county total)
- Development of a comprehensive bicycle and/or pedestrian facilities plan (once every 5 years)
- Quick Build Projects

This packet has been created to help guide local jurisdictions in submitting a successful application for funding.

The available funding for Napa County TDA-3 projects for FY 2026-27 and FY 2027-28 will be approximately \$450,000 dollars, with \$250,000 available in FY 2026-27 and \$200,000 in FY 2027-28, Applications are due to NVTA by 5:00 PM on Friday, May 1st 2025.

## **The TDA-3 Program**

The California State Legislature passed the Transportation Development Act (TDA) in 1971, which was subsequently signed into law by Governor Reagan. The TDA provides one of the major funding sources for public transportation in California. These funds are generated from a statewide ¼ cent sales tax. Article 3 of TDA is a set-aside of approximately 2% of those monies. Under Article 3 of the TDA, funds allocated to Napa County are available to local jurisdictions for bicycle and pedestrian projects.

The Metropolitan Transportation Commission (MTC) administers TDA 3, which is distributed based on population. Each year, an annual fund estimate or “entitlement” is developed for each County. A county’s claim in any given year cannot exceed the sum of their accumulated funds plus their projected entitlement for the following two years.

Funds are obtained by local jurisdictions via a three-step process: (1) apportionment, (2) allocation, and (3) payment (reimbursement). Apportionment in the San Francisco Bay Area follows a Metropolitan Transportation Commission (MTC) formula based upon population. Allocation is the discretionary action by MTC that designates funds for a specific claimant for a specific purpose. NVTA submits TDA allocation requests to MTC on a regular basis, and unused TDA funds allocated to any project may be rolled over from one fiscal year to the next. No matching funds are required, but the project must meet the funding objectives and be developed in cooperation with the community. The basic objectives of the grant source are to fund projects that increase the safety, security, and efficiency of bicycle and pedestrian travel, and to provide for a coordinated system. MTC requires supporting resolutions from the sponsoring Council.

This “Call for Projects” will be issued on April 18, 2026 upon approval by the NVTA Board of Directors. In addition to the application, project sponsors must provide documentation of environmental clearance and maps/documents showing project locations and design parameters. Projects must be approved by MTC.

TDA 3 projects are required to meet Caltrans safety design criteria and CEQA requirements; be completed within two years; be maintained; be consistent with adopted active transportation plans; and be authorized by a governing council or board. Local authorization is not required at time of application submission, but shall be due within 90 days of NVTA Board project approval and prior to annual submission of the Countywide TDA-3 claim to MTC.

As part of the grant process, MTC also requires the City Council to adopt a resolution making certain findings as follows:

- (i) There are no legal impediments regarding the project.
- (ii) Jurisdictional or agency staffing resources are adequate to complete the project.
- (iii) There is no pending or threatened litigation that might adversely affect the project or the ability of the project sponsor to carry out the project.
- (iv) Environmental and right-of-way issues have been reviewed and found to be in such a state that fund obligation deadlines will not be jeopardized.

- (v) Adequate local funding is available to complete the project.
- (vi) The project has been conceptually reviewed to the point that all contingent issues have been considered.

### **Basic Eligibility for TDA-3 Funding**

TDA Article 3 funds may be used for the following activities relating to pedestrian and bicycle facilities, including):

- Engineering expenses leading to construction.
- Right-of-way acquisition.
- Construction and reconstruction.
- Retrofitting existing bicycle and pedestrian facilities, including installation of signage, to comply with the Americans with Disabilities Act (ADA).
- Route improvements such as signal controls for cyclists, bicycle loop detectors, rubberized rail crossings and bicycle-friendly drainage grates.
- Purchase and installation of bicycle amenities such as:
  - secure bicycle parking,
  - benches, drinking fountains, changing rooms, rest rooms and showers which are adjacent to bicycle trails, employment centers, park-and-ride lots, and/or transit terminals and are accessible to the general public.
- Maintenance of Class I shared-use path or Class IV separated bikeways.
- Restriping of Class II bikeways. Countywide, the total funds allocated to Class II bikeway maintenance cannot exceed 20% of the total countywide TDA estimate
- Bicycle Safety Education Programs (and not more 5% of the countywide TDA Article 3 funds). Pursuant to NVTA Board policy, infrastructure projects are prioritized.
- Comprehensive Bicycle & Pedestrian Facilities Plans (not more than once per jurisdiction every 5 years)
- Projects identified in a recent (within 5 years) comprehensive local bicycle or pedestrian plan
- Quick-Build (also known as interim capital infrastructure) projects
- Capital purchases for maintenance of Class I or Class IV facilities (compact sweeping machine, blower, etc)
- Annual Audits in fiscal years funds are disbursed. Can be part of annual audit program, but must comply with additional TDA-3 requirements.

TDA Article 3 funds may not be used to fully fund the salary of any one person working on these programs.

### **Active Transportation Advisory Committee Requirement**

Cities and counties may not receive TDA Article 3 funds for projects unless the jurisdiction has established an Active Transportation Advisory Committee (ATAC) and the project is included in an adopted plan as stipulated in the MTC TDA Article 3 Policies and Procedures, [Resolution 4108](#). For Napa County, the NVTA Active Transportation Advisory Committee fulfills this requirement.

Note that for those jurisdictions with a local Active Transportation Advisory Committee, the approval of that committee is also required.

### **Project Selection Process**

The project selection process is as follows:

- NVTA staff will review prospective projects for eligibility based on TDA-3 requirements, and conduct a preliminary evaluation of cost-effectiveness, project readiness, potential to reduce serious/fatal collisions, and increase active transportation use. Staff will present their findings to the NVTA Active Transportation Advisory Committee (ATAC) which will serve as the initial selection and prioritization committee.<sup>1</sup>
- The ATAC recommendations will be forwarded to the NVTA Technical Advisory Committee (TAC) for their review and recommendation.
- The recommendation from both Committees will be forwarded to the NVTA Board for their decision.

### **TDA-3 Project Selection Criteria for Napa County**

For All Applications:

- The project provides a gap closure connecting two or more existing facilities.
  - Note that this criteria does not apply to Quick Build safety projects.
- The project is listed in the jurisdiction's adopted Bicycle or Pedestrian Plan, Local Roadway Safety Plan, the Countywide Vision Zero Plan, Safe Routes to School Plan, and/or related traffic safety or traffic calming program.

Preference will be given to projects that meet the following criteria:

- Provides a safe route to school and/or transit are located at or along an identified High Injury Network intersection or corridor
- Provide additional local matching funds (not required)

NVTA intends to prioritize applications for Quick Build projects for funding. Applicants with eligible Quick Build projects are advised to consult Caltrans guidelines for such projects.<sup>2</sup> NVTA staff are available to provide additional resources and consultation regarding such projects.

Additional screening criteria for Quick Build projects include:

- Limit of \$50,000 per project application

- Multiple applications for Quick Build projects may be submitted by a single jurisdiction
- Jurisdiction commitment to complete the project within 12 months
  - Failure to complete project within this timeframe may result in rescission of funds
- Jurisdiction commitment to maintain Quick Build improvements until permanent improvements are made (generally within 3 years). Removal of the project resulting in a return to prior conditions or functional equivalent require prior justification to MTC and NVTA.

### **Application Instructions:**

TDA-3 project applications for FY 2026-27 through FY 2027-28 must be submitted to NVTA no later than 5:00 pm on Friday, May 1st, 2025. Applications may be emailed to Patick Band at [pband@nvta.ca.gov](mailto:pband@nvta.ca.gov)

Applications must include:

- MTC project application
- An 8.5x11" map of the project area clearly showing location and extent of project improvements. Preliminary or conceptual design plans are appreciated, but not required.
- Minimum of 5 representative photographs of existing conditions

As noted elsewhere in this document, a Resolution of Local Support, identification of approved bicycle, pedestrian or other relevant supporting plan, and other materials will be required subsequent to application submittal for successful projects/programs.

**EXECUTIVE SUMMARY**

The Metropolitan Transportation Commission (MTC) approved the One Bay Area Grant (OBAG) Cycle 4 program guidelines for the local and county shares on February 25, 2026 via MTC [Resolution No. 4740 Revised](#). MTC also released funding targets for each county shown in Table 1 below. Funding for the Napa County call for projects is \$7.28 million. It should be noted that this amount is 120% of Napa County’s target to allow for the regional selection process.

Staff will review proposed OBAG 4 Call for Projects schedule, process and requirements to allow the TAC adequate opportunity to prepare for the upcoming release anticipated in May.

### **BACKGROUND**

MTC held a kick-off meeting with staff on March 13 to review OBAG 4 county program policies, timeline, evaluation criteria and project sponsor requirements. Once MTC confirms that the proposed county program process and materials meet requirements, staff anticipate releasing the Call for Projects at the May 20, 2026 NVTA Board meeting. Project nominations and a detailed description of public outreach compliance for the county program are due to MTC by October 31, 2026. The proposed schedule for OBAG 4 is shown in Attachment 1.

NVTA will solicit project applications (Attachment 2), and conduct an initial screening and prioritization of projects for Napa County. OBAG 4 nominations must meet the 50% Priority Development Area (PDA) investment requirement. In addition, NVTA will prioritize projects that align with regional plans and policies:

1. Are located in jurisdictions with affordable housing protection, preservation, and production strategies, including an emphasis on community stabilization and anti-displacement policies with demonstrated effectiveness
2. Invest in historically underserved communities, including projects prioritized in a Community-Based Transportation Plan (CBTP) or projects located within Equity Priority Communities with demonstrated community support
3. Address federal performance management requirements by supporting regional performance goals for roadway safety, asset management, environmental sustainability, or system performance
4. Implement multiple Plan Bay Area 2050+ Strategies
5. Demonstrate consistency with other regional plans and policies, including the Regional Safety/Vision Zero policy, Equity Platform, Regional Active Transportation Plan, Transit Oriented Communities (TOC) policy, and the Transit Transformation Action Plan and Transit Priority Policy for Roadways
6. Demonstrate public support from communities disproportionately impacted by past discriminatory practices, including redlining, racial covenants, urban renewal, and highway construction that divided low-income and communities of color

7. Can be completed in accordance with MTC's Regional Project Delivery Policy ([MTC Resolution No. 3606](#)) and can meet all OBAG 3 deadlines, and federal and state delivery requirements

Local evaluation criteria will address:

- Needs and benefits: with consideration for safety, multi-modal access, emissions, resilience, stormwater management, and state of good repair
- Local priority/community support: Demonstrated through CBTPs, PDA plans, other local plans, letters of support, etc.
- Equity impacts: including benefits to EPC's or similar local designations, ADA Transition Plan alignment, etc.
- Leveraging local funds: Additional match beyond the 11.47% requirement
- Capacity to deliver the project: Meet timely use of funds requirements
- Ability for project to improve multimodal connectivity and access: Gap closures, transit access improvements, etc.

After completing initial project screening and evaluations, NVTA will submit prioritized project nominations and required documentation to MTC by October 31, 2026. Prioritized nomination lists must be approved by the NVTA Board prior to submission to MTC. An evaluation panel of MTC staff will evaluate all project nominations and develop a recommended program of projects for Commission consideration and approval.

MTC will consider the following criteria when evaluating OBAG 4 county program nominations:

- CTA Priorities (**75 points**): CTA scores normalized across counties
- Regional Alignment: *Support for Plan Bay Area 2050+* strategies, the Regional Safety/Vision Zero Policy ([MTC Resolution No. 4400](#)), the Complete Streets Policy ([MTC Resolution No. 4493](#)), the Bay Area Transit Transformation Action Plan, and the regional Transit Priority Policy for Roadways (anticipated)
- Federal Performance Goals: Improvements to safety, infrastructure condition, system reliability, freight movement and economic vitality, congestion reduction, and environmental sustainability (23 U.S.C. § 105(b)).
- Deliverability and Risk: Sponsor capacity and expertise, recent delivery of regional funds, and risks to the project schedule or delivery plan
- Air Quality Benefits: The relative cost-effectiveness in reducing criteria air pollutants, for CMAQ-eligible projects for the purpose of assigning CMAQ funding consistent with federal requirements.
