### 4. Committee Member Comments

Lorien Clark, City of Napa - the City posted a project webpage on its website for the Jefferson Corridor Transportation Safety and Mobility plan that includes a community survey, she invited the TAC to complete the survey.

Steve Lederer, County of Napa - the County is ready to start paving projects on Partrick, Solano, Deer Park, White Cottage, College, along with several storm repair projects. The County is also working with the City of Napa on Imola, and the City of American Canyon on South Kelly and Tower on upcoming paving projects. A paving project on Devlin Road from Soscol Ferry intersection to the Chevron station may start next week, and most of the work will be done at night.

Eric Janzen, City of St. Helena - The City hired James McCann to serve as interim city manager during the search for a city manager.

Mike Ryan, City of Napa - the Trancas paving project is underway, and the Soscol paving project will be awarded in a few weeks.

Derek Rayner, City of Calistoga - the City completed some maintenance and tree work on the Vine Trail, however, a small section of the Vine Trail before Main Street is closed due to underground utility projects; a detour is in place. The City also has a pipeline and repaving project on Lincoln Avenue. Additionally, the City signed a one-year contract with Mitch Celaya to serve as City Manager.

Erica Ahmann-Smithies, City of American Canyon - the Green Island Road project is well under way, there will be a 55-hour shut down in a few weeks. Melbourne Road sidewalk drainage and rehabilitation/traffic calming project is completed.

## 5. Staff Comments

Patrick Band noted the NVT Board adopted the Countywide Active Transportation Plan at its April 15 meeting. The next step is the local adoption phase, and he is coordinating with each jurisdiction to have that completed by the end of summer.

Mr. Band thanked the County of Napa for incorporating a bus pad connection to an existing sidewalk near the Chevron location on Devlin Road.

### 6.1 County Transportation Agency Report (Diana Meehan)

Diana Meehan provided updates on the following topics covered at the April 24 County Transportation Agency (CTA) meeting:

#### Caltrans Updates:

- Updated Notice of Funding Opportunities (NOFO)
- Safe Streets for All (SS4A) Program announcement-applications are due May 26, program has approximately \$993M (award ceiling is \$25M, award floor is \$100K) two program components: Planning and Demonstration and Implementation—see the NOFO for more information
- Amjad Naseer was appointed as the District Division Chief-System Operations

#### Metropolitan Transportation Commission (MTC) Updates:

- Equity Priority Community (EPC) Refresh Project - will begin this summer starting with 1:1 meeting with CTAs. MTC will use the same framework including creating a tool to provide clear definitions of displacement/gentrification. The project kicks off this month, the initial phase will take approximately 18 months.
- Plan Bay Area Kick off this Fall (PBA 2060). This will be a major update and will focus on process/scope/priorities.

Eric Janzen reported that the Napa Valley Vine Trail Coalition (NVVTC) installed an electronic wayfinding kiosk on Main Street in the City of St. Helena, final approval from the City is still pending.

Additionally, NVVTC met with the City of St. Helena to discuss alternatives to traffic calming measures slated on Oak Avenue as part of the St. Helena segment.

Grant Bailey provided updates on the Napa Valley Forward - Oakville Crossroad project, SR 29 American Canyon Corridor and the SR12/29/Airport Boulevard and SR12 and Kelly Road intersections.

Member Lederer expressed concern that the Oakville Crossroad project and Caltrans' Rutherford Crossroad bridge replacement may happen concurrently. Caltrans staff will provide Grant Bailey with the program year for the bridge replacement.
